The work will be performed by McGovern Inc. in accordance with the applicable guidelines adopted by the Pennsylvania Septage Management Association (PSMA) for conducting Level 1 septic inspections. We strongly recommend that you (or McGovern Inc. on your behalf) obtain a complete copy of the septic system permit PRIOR to the appointment. In Chester County contact 610-344-6526, or in other counties contact the local township.

The cost of the septic system inspection is indicated below: whether we are ABLE or UNABLE to verify that the system is currently functioning in a satisfactory manner and regardless of the success or failure of a transaction between buyer and seller. <u>Note:</u> Water must flow from the home into the treatment tank to perform the inspection. The home cannot be winterized.

Additional cost may be incurred if there are exceptions to the usual inspection process, which is required to complete the septic inspection. These may include but are not limited to the following: More than one tank, dual compartment septic tanks, access covers 6"or more below grade (see digging charges), or larger than 28" in diameter; Snaking pipes, the use of radio transmitters and video cameras; Drip Irrigation and large trench systems; Exceptionally deep, rocky, frozen, snow covered, overgrown or inaccessible ground conditions; Locating un-marked septic tanks and cesspools; More than one visit to the inspection site; Hydraulic Load Testing; waste removal (see pumping charges). Other than an additional cost to hand dig and access tanks on the day of the inspection, you will be notified prior to any work performed.

Because of the numerous factors which may affect the proper operation of the septic system, as well as the inability of McGovern Inc. to supervise or monitor the functions, or the maintenance of the system, this inspection and the report to be issued do not constitute and shall not be construed as a warranty by McGovern Inc. that the system will function properly for any particular period of time or for any particular prospective buyer. This report is being provided to the client as a comprehensive and objective evaluation of the on-site waste water treatment system on the day of the inspection.
